Data Summary and the Procedure for Responding to Public Inquiries

Halton's <u>Environmental Source Information Database</u> is a directory of documented sites and records in the Region that have the potential to contaminate the surrounding environment. The database includes information regarding current and historic land uses and activities that could be hazardous, environmental occurrences, incidents and other information related to the environmental condition of a site in Halton Region.

Data requests for this information must be submitted in writing via e-mail along with the completed and signed waiver. Please include a location map of the subject property including property boundary lines and major road intersections nearby.

Data for this inventory includes information from the following sources:

- Halton Region Planning Services' Geographical Information System (GIS)
- · Regional Planning Files,
- Halton Region's Business Directories, Chamber of Commerce Business Directories
- Technical Standards and Safety Authority's Inventory of Retail Fuel Storage Tanks
- Environment Canada's National Pollutant Release Inventory
- MECP's records on:
 - Hazardous Waste Information System (Carriers, Generators, and Receivers)
 - Certificate of Approvals or Environmental Compliance Approvals
 - Waste Disposal Site/Landfill Inventory
 - Inventory of PCB Storage Sites
 - Spills Action Centre Inventory
 - Pesticide Licensee Database
- Environmental Bill of Rights
- Fire Insurance Plans

The **ESI Database Product Fee for 2022** is \$181.59 (includes HST) per parcel, which can be paid via Electronic Funds Transfer (EFT), or credit card. The Region also requires a signed waiver (attached) before the data will be released. If the inquiry relates to more than one parcel of land, separate inquiries must be submitted.
