- ✓ No member of the household is currently under a deportation, departure or exclusion order to leave Canada.
- ✓ Household income must not exceed the income limit for Halton Region.
  - Household Income Limits are determined by the Housing Services Act
- ✓ Household assets must not exceed the asset limit for Halton Region.
  - asset limit is \$50,000 for one person and \$75,000 for two or more people
- ✓ No member of the household owes money to a social housing provider.
- ✓ No member of the household has been convicted of an offense within the past two years under the *Housing Services Act*, 2011 (HSA), the *Social Housing Reform Act* or the Criminal Code in relation to the receipt of Rent-Geared-to-Income assistance.
- ✓ You must be able to live independently, with or without supports.





### Frequently asked questions

### How long will I be waiting to get housing in Halton?

In Halton Region, like in other communities, it can often take a number of years before government assisted housing becomes available. Placements from the HATCH wait list are made based on when the applications are received. Wait times depend on the number of communities and properties selected by a HATCH applicant and the number of vacancies that become available.

### How does Halton select wait list applicants for housing?

Halton Region offers housing based on the date of the application. Individual housing providers have a subsidized housing wait list for their property and contact the next eligible applicant directly when there is a vacancy so they can view the unit.

### What happens while I am waiting for housing?

It is important to keep your application up-to-date. Every other year, HATCH will send you an Application Update Form. This document must be completed and returned to HATCH by the deadline listed on the form.

# You may report changes to your application to HATCH at any time. This includes changes to:

- your address and/or phone number;
- the number of people in your household;
- the contact person on your application; and
- your household income.

### Keeping your application up to date

Every other year, HATCH will send you an Application Update Form. This document must be completed and returned to HATCH by the deadline listed on the form.

You are required to notify HATCH within 30 business days of any changes to your application.

You must accept the first HATCH unit that is offered from the buildings you have selected to live in. If you do not accept your first offer of housing, you will be removed from the HATCH waitlist and you will need to re-apply with a new application date.

Important: Applications that are not updated may be cancelled and your name may be removed from the HATCH wait list.
