About This Project

To increase the resilience of the community's wastewater collection system, Halton Region is making investments to help reduce stormwater infiltration and reduce the risk of future basement flooding. Through the multi-year Basement Flooding Mitigation Program, the Region is making improvements to wastewater mains, laterals and maintenance holes in the City of Burlington, Town of Halton Hills, Town of Milton, and Town of Oakville. The Region assigns streets to Parts A, B (**this project**), and C of the Basement Flooding Mitigation Program, prioritizing based on infrastructure conditions and the overall risk of basement flooding.

Under the Basement Flooding Mitigation Program (BFMP) Part B, Halton Region is planning to improve the wastewater collection system within Ward 2, in the Town of Oakville. The project is reviewing wastewater assets along **Brant Street, Burnet Street, Walker Street, Taplow Crescent, Brookfield Crescent and Rebecca Street** with limits of the work identified in the attached map.

As part of this project's design process, starting Fall 2022, Halton Region staff will be surveying, locating and marking aboveground and underground infrastructure within this area. ***Please do not disturb any stakes or paint markings from your property. Our staff will remove them once the survey work is completed.***







