Study

Halton Region has completed a Municipal Class Environmental Assessment (EA) Study to address future travel demands on the Trafalgar Road (Regional Road 3) corridor from Cornwall Road to Highway 407, in the Town of Oakville. The study has been conducted in compliance with Schedule C of the Municipal Class Environmental Assessment (October 2000, amended 2007 & 2011), which is approved under the Ontario Environmental Assessment Act.

Taking into consideration the comments that were received from the Town of Oakville, regulatory agencies and the public, Halton Region is recommending a preferred design, which includes the widening of Trafalgar Road to a six-lane urban cross section north of Iroquois Shore Road/Leighland Avenue, including intersection improvements, raised median and multi-use paths/sidewalks.

Process

The Environmental Study Report (ESR) has been prepared to document the planning, public consultation and decision-making process undertaken for this study. By this Notice, the ESR is being placed on the public record for a 30-day review period in accordance with the requirements of the Municipal Class EA. Subject to comments received as a result of this Notice and the receipt of necessary approvals, Halton Region intends to proceed with the detail design and widening of Trafalgar Road as documented in the ESR.

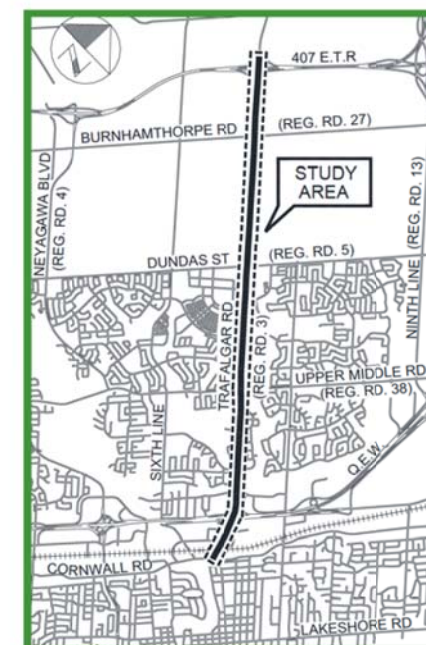
