About This Project

IMPROVEMENTS

Further to the Region's last notice on July 21, 2020, this Notice provides an update on the wastewater collection system enhancements planned by Halton Region within Ward 2, in the City of Burlington.

Design work is currently in progress and construction is now tentatively scheduled for fall 2022. Another notice will be distributed once the contract is awarded and a more precise construction start date is confirmed. The Region will continue to provide updates on the status of this project as it proceeds to construction.

The purpose of this project is to mitigate basement flooding risks by rehabilitating existing wastewater infrastructure. The project will occur along the following streets, with limits of the work identified in the attached maps:

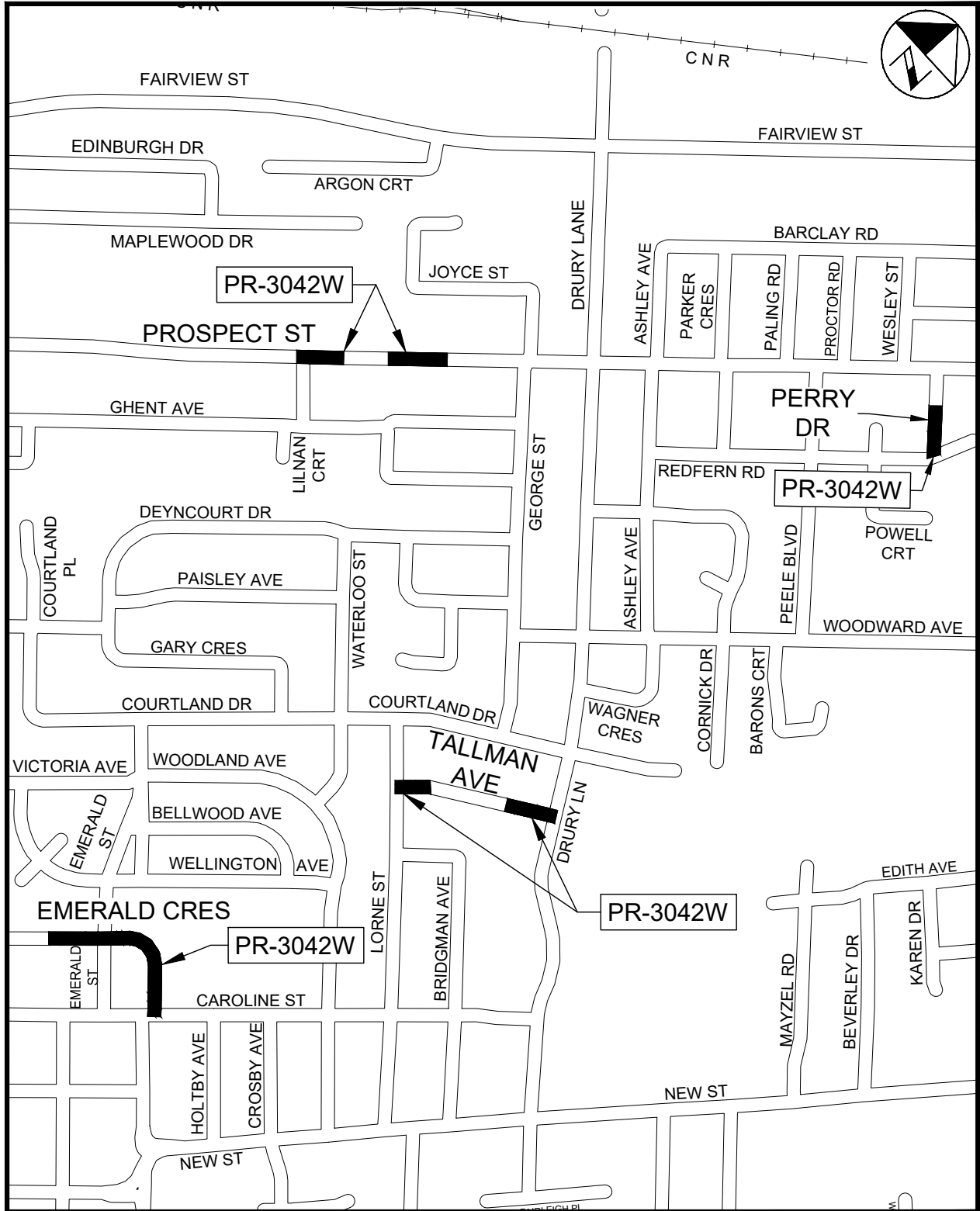

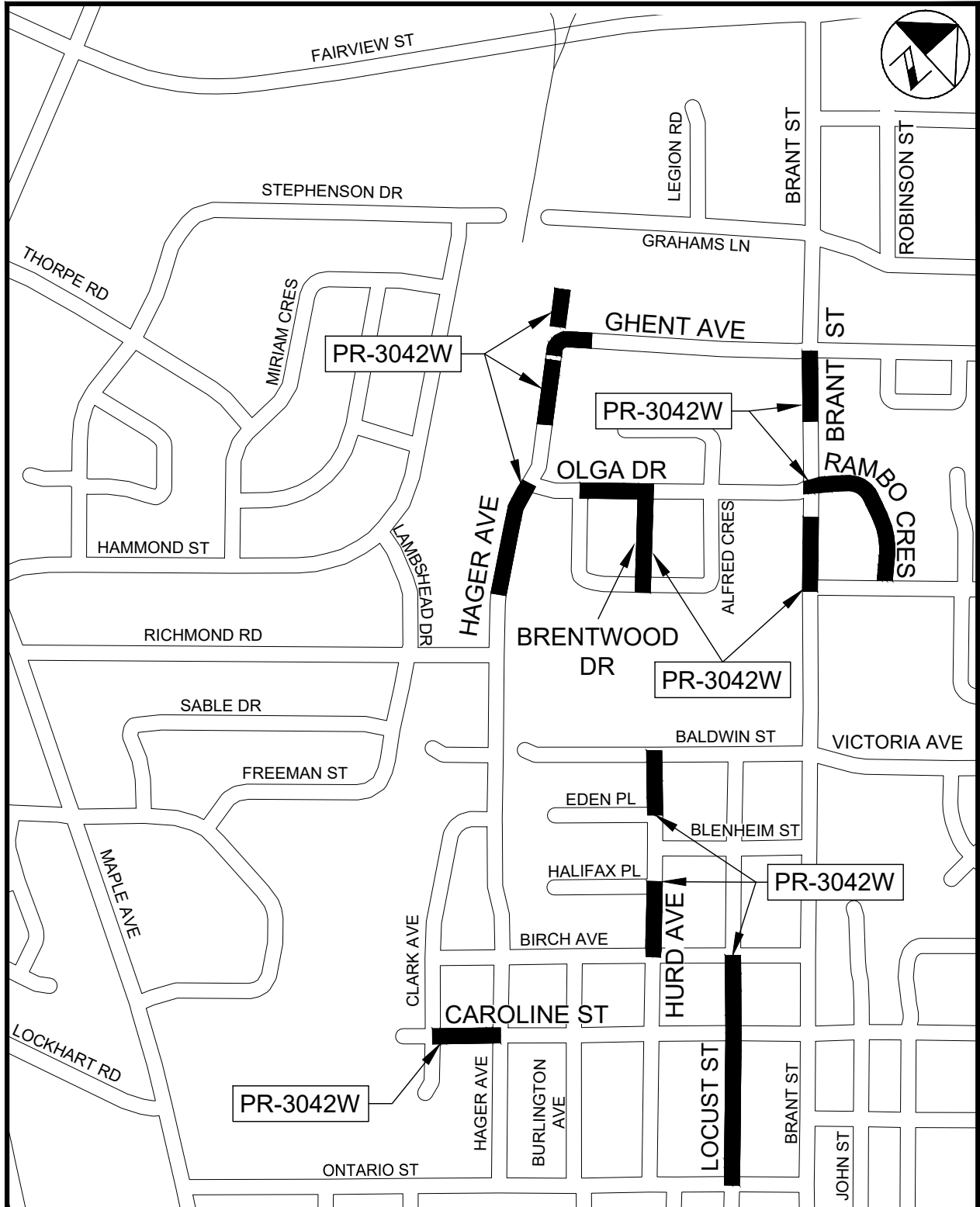


BASEMENT FLOODING MITIGATION PROGRAM - PART A

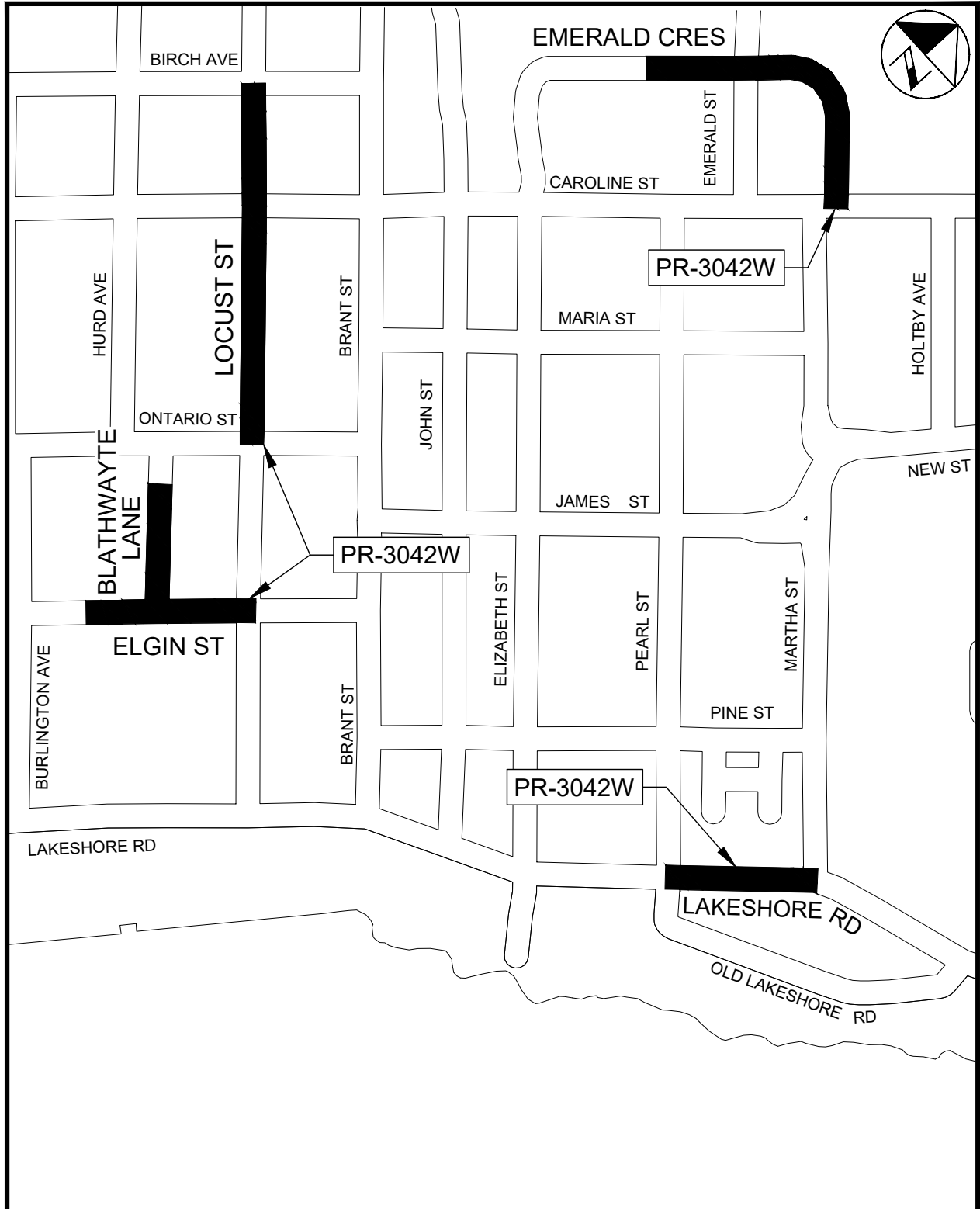

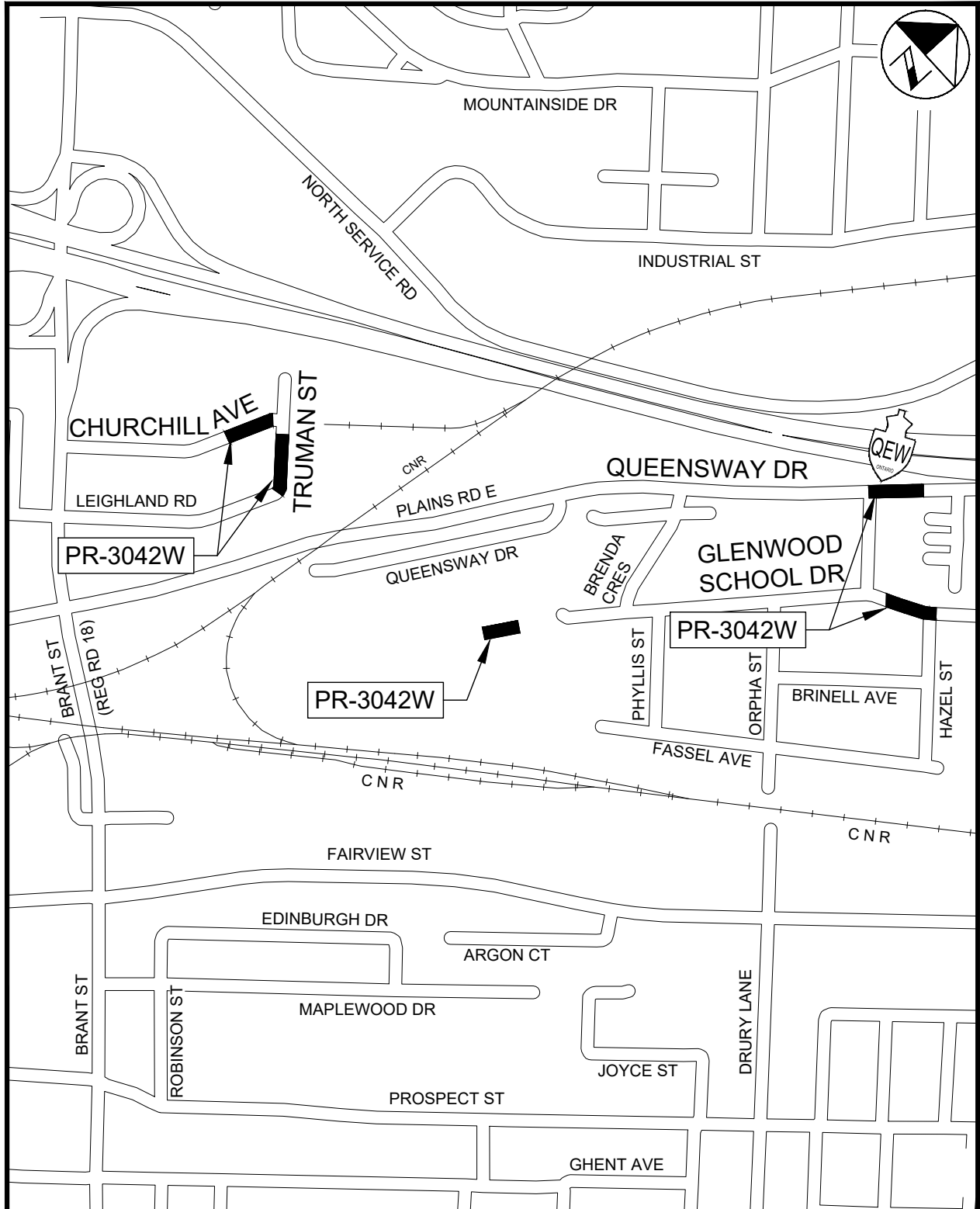
