RE: Human Rabies Case in Ontario - CMOH Memo to Hospitals and Primary Care Providers

## QUICK FACTS

- There has been a confirmed case of rabies in an Ontario resident. The Office of the Chief Medical Officer of Health issued a <u>memo to all hospitals and primary care providers in Ontario</u>. This marks the first domestically-acquired case of human rabies in Ontario since 1967.
- The individual is a resident of Brantford, and Brant County Health Unit issued the following announcement: <u>Brant County Health Unit Confirms Rabies Case in Brantford-Brant Resident -</u> <u>Brant County Health Unit (bchu.org)</u>.
- Prompt assessment and appropriate administration of post-exposure prophylaxis (PEP) following a suspected rabies exposure is critical because once symptoms develop, rabies is almost always fatal.

## **KEY MESSAGES FOR HEALTHCARE PROVIDERS**

- Continue to report all potential rabies exposures to Halton Region Public Health as required under the <u>Health Protection and Promotion Act</u>. This includes cat and dog scratches/bites and contact with wildlife such as bats, raccoons, skunks and other mammals.
  - Call 311 AND fax a completed Rabies Exposure Reporting Form to 905-825-8797 24/7, 365 days a year.
- Upon receipt of a potential rabies exposure, a Public Health Inspector will investigate and assist the clinician in a risk assessment of the exposure and the need for rabies PEP. Guidance on whether a patient may require rabies PEP can be found in the <u>Management of Potential Rabies</u> <u>Exposures Guideline, 2020 (gov.on.ca)</u>.
- Bites inflicted by bats may not be felt and may not leave behind any visible marks.
- The decision to administer PEP sits with the attending physician, in consultation with their patient.

## **KEY MESSAGE FOR PATIENTS**

Patients with questions about rabies can visit Halton Region's <u>Bats and Rabies</u> webpage or call 311 and ask to speak to a Public Health Inspector.

Please report all suspected/confirmed cases of <u>Diseases of Public Health Significance</u> (only report COVID-19 cases occurring in high-risk settings) to Public Health immediately by calling 311, 905-825-6000 or toll free at 1-866-442-5866.
